## TECHNICAL COOPERATION ACTIVITIES: INFORMATION FROM OTHER INTERGOVERNMENTAL ORGANIZATIONS

UNITED NATIONS CONFERENCE ON TRADE AND DEVELOPMENT (UNCTAD)

At its meeting of 14-15 June 2023, the Council for TRIPS agreed to invite intergovernmental organization observers to the Council to update the information on their technical and financial cooperation programmes relating to the implementation of the TRIPS Agreement.

The present document reproduces the information which has been received from the United Nations Conference on Trade and Development (UNCTAD) by means of a communication dated 17 September 2023.

## **INTRODUCTION**

- 1. The UNCTAD Secretariat, in accordance with its mandate under Bridgetown Covenant (2021) and taking into account international and regional initiatives, such as those by the World Intellectual Property Organization (WIPO), World Health Organization (WHO), and the African Union, implements a work programme on advancing the development dimension of intellectual property (IP) rights as they relate to key economic sectors. The work programme is implemented by its Intellectual Property Unit, located within the Division on Investment and Enterprise.
- 2. UNCTAD focuses on improving the effective participation of developing countries in international IP norm setting, upgrading national IP policies and advancing regional cooperation on IP rights. It also works on building coherence between IP, investment and trade policies to meet the Sustainable Development Goals, to address the changes brought by frontier technologies and to build productive capacity in vital sectors of developing countries' economies, with a priority on the bio-pharmaceutical and vaccine sectors. The work programme is partially funded by donor governments and institutions. Currently, the work programme targets technical assistance and capacity building in areas related to: (1) local pharmaceutical and vaccines production, including in the context of COVID-19 and anti-microbial resistance (AMR); and (2) regional and national IP policies.

To seizure the opportunities, the event demonstrated the need to translate plans into action; to address market shaping mechanisms to ensure sustainability; accelerate the rolling out of investment finance and programmes for skills development; and increase the opportunity for business-to-business interactions.

Brief description	UNCTAD in collaboration with the EAC Secretariat organized a regional experts' workshop on the development of draft regional policy framework for the promotion of antibiotics production and supply in the East African Community (EAC). The main objectives of the regional workshop were (1) for regional experts to provide input for a policy framework on promotion of production and supply of antibiotics with key stakeholders and (2) enhancing regional cooperation for information exchange and pooled procurement of antibiotics.
Beneficiary institution or audience	The participants included representatives of EAC partner states from the Ministry responsible for Industrialization (Focal person for Pharmaceuticals); Ministry of Health (Focal person responsible for pharmaceutical production policy); National Medicines Procurement Agency; National Pharmaceutical Manufacturers' Association and development Partners (ReAct Africa- Action on Antibiotic Resistance, GARDP Africa- Global Antibiotic Research and Development Partnership, United Nations Economic Commission for Africa and World Health Organization)

Outputs or impact	The regional experts adopted two instruments: (1) Draft Policy Framework on Production and Supply of Antibiotics; and (2) Regional cooperation mechanism for information exchange on supply of antibiotics. The two instruments were adopted by the 38th Extra Ordinary Sectoral Council on Trade, Industry, Finance, and Investment (SCITIFI) on 1st April 2023 (EAC/ExSCTIFI 38/Decision 5 and EAC/ExSCTIFI 38/Decision 6). Following the adoption of the regional instruments, UNCTAD organized a series of capacity building and national consultation workshops in collaboration with EAC Secretariat in Rwanda (16-17 May 2023), Burundi (18-19 May 2023), Tanzania (22-23 May 2023), Uganda (19-21 July 2023), South Sudan (24 July 2023) and Kenya (25-27 July 2023).
