### **REPORT (2023) OF THE COUNCIL FOR TRADE IN GOODS**

In accordance with the "Procedures for an Annual Overview of WTO Activities and for Reporting under the WTO" (WT/L/105), the Council for Trade in Goods (CTG, or the Council) is to prepare an annual report each year to the General Council on the activities in the Council as well as those in its subsidiary bodies. The reports are to be "factual in nature, containing an indication of actions and decisions taken, with cross-references to reports of subordinate bodies and could follow the model of the GATT 1947 Council reports to the CONTRACTING PARTIES".

Since its 2022 Annual Report (G/L/1463) was issued, the CTG met three times in formal session on the following dates: 3-4 April 2023<sup>1</sup>; 6-7 July 2023<sup>2</sup>; and 30 November-1 December 2023<sup>3</sup>. Furthermore, the CTG met six times in informal mode, to consider the slate of names for the appointment of Chairpersons of the CTG's subsidiary bodies on 5 June 2023<sup>4</sup>; and to discuss MC12 implementation matters on 31 January 2023<sup>5</sup>; 27 February 2023<sup>6</sup>; 31 March 2023<sup>7</sup>; 31 May 2023<sup>8</sup>; and 19 September 2023.<sup>9</sup>

### 1 ELECTION OF CHAIRPERSON OF THE COUNCIL FOR TRADE IN GOODS

1.1. At its meeting of 3-4 April, the Council elected by acclamation Ambassador Dr Adamu Mohammed Abdulhamid (Nigeria) as its Chairperson for 2022-2023.

#### 2 APPOINTMENT OF OFFICERS FOR THE SUBSIDIARY BODIES OF THE COUNCIL

- 2.1. At its meeting of 3-4 April, the Council suspended this agenda item pending further consultations. The process continued to be conducted by the then outgoing Chairperson of the Council for Trade in Goods, Mr Etienne Oudot de Dainville.
- 2.2. The Council reverted to this agenda item on 5 June<sup>10</sup>, when the Chairperson reported that consensus on the slate of names had been reached, and the Council for Trade in Goods agreed on the nominations of the following persons for election as Chairpersons of the subsidiary bodies of the Council for Trade in Goods for 2023-2024:

#### **3 MARKET ACCESS ISSUES**

## 3.1 Collective waiver requests on the introduction of the Harmonized System 2002, 2007, 2012, 2017, and 2022

3.1. At its meeting of 30 November, the Council considered four requests for an extension of the collective waivers in connection with the introduction of Harmonized System 2002, 2007, 2012, 2017 and 2022 changes into WTO Schedules of Concessions. The Council approved the waiver extension requests and recommended that the draft decisions contained in documents G/C/W/831, G/C/W/832, G/C/W/833, G/C/W/834, and G/C/W/835/Rev.1 be forwarded to the General Council for adoption.

## 5 STATUS OF NOTIFICATIONS UNDER THE PROVISIONS OF THE AGREEMENTS IN ANNEX 1A OF THE WTO AGREEMENT (G/L/223/REV.30)

5.1. At its meeting of <u>3 April</u>, the Council took note of document G/L/223/Rev.30, informing Members about the status of notifications under the provisions of the Agreements in Annex IA of the WTO Agreement. In addition, the Chairperson drew Members' attention to the online Notifications Portal (<a href="https://notifications.wto.org/en">https://notifications.wto.org/en</a>), which sought to consolidate, under a single system, all general information concerning notifications and the information for the agreements on trade in goods summarized and presented following the template of document series G/L/223/\*.

# 6 MEMBERS' NON-RESPONSIVENESS TO QUESTIONS POSED BY OTHER MEMBERS AND MEMBERS' NON-NOTIFICATIONS OF ITEMS PURSUANT TO CERTAIN WTO AGREEMENTS – REQUEST FROM THE UNITED STATES

6.1. At its meetings of <u>3 April</u>, <u>6 July</u>, and <u>30 November</u>, the United States requested the inclusion of two new agenda items, each including annexes with lists of those Members that have questions outstanding in CTG subsidiary bodies and non-notifications of items pursuant to certain WTO Agreements.<sup>11</sup> The United States reminded Members of their obligation to comply with their transparency obligations, and encouraged those Members requiring assistance and guidance to reach out to the Secretariat or other Members. The Council took note of the statements made by the various Members that took the floor.

# 7 MEASURES TO ALLOW GRADUATED LDCS, WITH GNP BELOW USD 1,000, BENEFITS PURSUANT TO ANNEX VII(B) OF THE AGREEMENT ON SUBSIDIES AND COUNTERVAILING MEASURES (WT/GC/W/752)

- 7.1. At its meeting of <u>6 July</u>, the Council took note of the statements made by Bangladesh, on behalf of the LDC Group, and supported by Nepal, reiterating their request to Members to consider the proposal to allow graduated LDC Members to benefit from the exception provided under Article 27.2(a) of the SCM Agreement to developing Members listed in Annex VII(b); and clarified that the LDC Group's proposal on graduation submitted to the General Council was contained in document <u>WT/GC/W/807/Rev.2</u>; and that the specific item on the ASCM in the LDC Graduation proposal would depend on a CTG decision. The United States noted information gaps and remained available to engage with the LDC Group, as did the European Union.
- 7.2. At its meeting of <u>30 November</u>, the Council took note of the statements made by Djibouti, on behalf of the LDC Group, and supported by Bangladesh and Nepal, reiterating their request to Members to consider the proposal to allow graduated LDC Members to benefit from the exception provided under Article 27.2(a) of the SCM Agreement to developing Members listed in Annex VII(b). The United States reiterated that gaps in the information needed for the consideration of this proposal remained. The European Union noted that they remained available to engage with the LDC Group to explore a solution in this context.

# 8 PRINCIPLES GUIDING THE DEVELOPMENT AND IMPLEMENTATION OF TRADE-RELATED ENVIRONMENTAL MEASURES – COMMUNICATION FROM THE AFRICAN GROUP (G/C/W/830)

8.1. At its meeting of 30 November, the Council took note of the communication from the African Group on Principles Guiding the Development and Implementation of Trade-Related Environmental Measures, set out in document G/C/W/830. On behalf of the LDC Group, Djibouti noted that the document sets out important principles which should be recognized at the WTO in order to guarantee that efforts aimed at implementing measures in favour of trade and the environment do not lead to damaging consequences, particularly for LDCs and developing countries. Several Members thanked the African Group for their communication, expressing their interest in continuing the dialogue on trade-related environmental policies. While recognizing the importance of more transparency and dialogue on trade-related environmental policies, other Members were of the view that prescriptive principles for engagement were not necessary in the WTO, and observed that the principles referred

to in the African Group's paper belong to different legal regimes and do not necessarily apply to every environmental policy being implemented.

## 9 G20 TRADE AND INVESTMENT MINISTERS' MEETING – UPDATE INCLUDING JAIPUR CALL ON ACTION FOR MSMES – REQUEST FROM INDIA

9.1. At its meeting of <u>30 November</u>, the Council took note of the updates presented by India concerning the G20 Trade and Investment Ministerial Meeting held in August 2023, which had resulted in a Ministerial Declaration, including the Jaipur Call for Action, for enhancing access to information for MSMEs. More information about these outcomes, and how they could be relevant to the WTO's ongoing work were presented in room documents RD/MA/120 and RD/MA/121. The European Union, Switzerland, and the United States underlined the importance and the work they are engaged in on the topic, and expressed their interest and support for the implementation of the Jaipur Call for Action and the ongoing work by the ITC in this field, together with UNCTAD and the WTO.

## 10 ACCESSION OF THE REPUBLIC OF ARMENIA AND OF THE KYRGYZ REPUBLIC TO THE EURASIAN ECONOMIC UNION (EAEU): PROCEDURES UNDER ARTICLE XXVIII:3 OF THE GATT 1994

# 10.1 Accession of the Republic of Armenia to the Eurasian Economic Union: Procedures under Article XXVIII:3 of the GATT 1994 – Communication from Armenia (G/L/1110/Add.9)

10.1. At its meeting of <u>30 November</u>, the Council took note of the information provided by Armenia relating to its renegotiations under Article XXVIII:3 of GATT 1994, following its accession to the Eurasian Economic Union (EAEU), and considered the extension of the deadline set out in document G/L/1110/Add.9. The Council took note of the statements made by Armenia and approved the requested extension until 2 January 2025.

# 10.2 Accession of the Kyrgyz Republic to the Eurasian Economic Union: Procedures under Article XXVIII:3 of the GATT 1994 – Communication from the Kyrgyz Republic (G/L/1137/Add.8)

10.2. At its meeting of 30 November, the Council took note of the information provided by the Kyrgyz Republic relating to its renegotiations under Article XXVIII:3 of GATT 1994 following its accession to the EAEU and considered the extension of the deadline set out in document G/L/1137/Add.8. The Council took note of the statement made by the Kyrgyz Republic and approved the requested extension until 12 February 2025.

### 11 TRADE CONCERNS

- 11.1. At its meeting of  $\underline{3 \text{ April}}$ , 41 trade concerns were brought to the Council's attention (see Annex 1), including the following four new trade concerns:
  - i. United States, Japan, Netherlands US-Japan-Netherlands Agreement on Chip Export Restrictions Request from China;
  - ii. United States Section 301 Tariffs on Certain Goods from China Request from China;
  - iii. United States Disruptive and Restrictive Measures in the Name of National Security Request from China; and
  - iv. India Implementation of Conformity Assessment Policy through Quality Control Orders (QCOs) in Various Sectors Request from Canada and the European Union.
- 11.2. At its meeting of <u>6 July</u>, 37 trade concerns were brought to the Council's attention, all of them previously raised concerns. The full list of trade concerns considered at the 6 July CTG meeting is provided in Annex 2.

- 11.3. At its meeting of 30 November, 44 trade concerns were brought to the Council's attention (see Annex 3), including the following 8 new trade concerns:
  - India Import Licensing Measures on PCs, Tablets, and other Electronic Products -Request from China;
  - ii. European Union - The Anti-Subsidy Investigation Against the Imports of Battery Electric Vehicles from China - Request from China;
  - iii. India - Quality Control Order for Chemical and Petrochemical Substances - Request from Thailand;
  - France Revised Electric Vehicle (EV) Subsidy Scheme Request from the Republic of iv. Korea:
  - Peru Tax Treatment of Pisco Request from the United Kingdom; ٧.
  - vi. China; Hong Kong, China; Macao, China; and the Russian Federation - Restriction on Imports of Aquatic Products from Japan after Discharge of ALPS Treated Water into the Sea - Request from Japan;
  - vii. India – Viscose Staple Fiber (VSF) Import – Request from Indonesia; and
  - European Union Anti-Dumping on Fatty Acid Request from Indonesia. viii.

### 12 MC12 IMPLEMENTATION MATTERS: FUNCTIONING OF THE CTG AND ITS SUBSIDIARY **BODIES AND WTO RESPONSE TO THE PANDEMIC**

- 12.1. The CTG has held five informal meetings to discuss CTG-related MC12 implementation matters: 31 January 2023 (ICN/CTG/7, ICN/CTG/7/Add.1, and JOB/CTG/20); 27 February 2023 (ICN/CTG/8, ICN/CTG/8/Suppl.1, and JOB/CTG/23); 31 March 2023 (ICN/CTG/9, ICN/CTG/9/Add.1, ICN/CTG/9/Suppl.1, and JOB/CTG/27); 31 May 2023 (ICN/CTG/10, ICN/CTG/10/Suppl.1 and JOB/CTG/28); and 19 September 2023 (ICN/CTG/12, ICN/CTG/12/Suppl.1 and JOB/CTG/37).
- 12.2. At its formal meetings of <u>3 April</u>, <u>6 July</u> and <u>30 November</u>, the Chairperson reported on the work undertaken in this area. 12
- 12.3. Regarding the functioning of the CTG and its subsidiary bodies, the CTG agreed to implement 27 changes with a view to improving its functioning, including 13 adopted through formal decisions<sup>13</sup> and 14 where the Secretariat introduced changes to the way in which it supports the work of the Council following discussions with Members. The CTG's 14 subsidiary bodies submitted written reports summarizing their discussions and describing the improvements made since the conclusion of MC12. These reports have been collected and consolidated into a comprehensive draft report for the Goods area overall in document JOB/CTG/39/Rev.3. At its formal meeting of 30 November, the Council considered the draft report and agreed to transmit this report to the General Council for consideration at its December meeting. The adopted version of the report was circulated in document G/L/1523.

13 (i) An extension to 15 calendar days for requesting the inclusion of an agenda item; (ii) separating the trade concerns in the agenda as new and previously raised; (iii) including CTG trade concerns in the Trade Concerns Database; (iv) the introduction of the eAgenda on a trial basis; (v) the preparation of an annotated agenda for the 30 November meeting; (vi) default option for statements in the eAgenda; (vii) online availability of all documents in all three WTO languages for consideration during a meeting; (viii) encouraged online availability of presentations in all three WTO languages for consideration during a meeting; and (ix) annual WTO Digital Tools Overview Session. At the formal meeting of 30 November, it agreed new improvements relating to (i) the information regarding informal meetings; (ii) the Chairperson's follow-up note on actions following formal meetings; (iii) the CTG information hub; and (iv) the format and contents of the convening notice (Airgram). See G/C/M/145 section 7, JOB/CTG/27 and JOB/CTG/28; G/L/1481; G/C/M/146 Section 4; <u>JOB/CTG/38</u>; <u>G/L/1490</u>, <u>GL/1522</u> and G/C/M/147 (to be issued).

- 12.4. Regarding the **WTO Response to the COVID-19 Pandemic**, the Secretariat prepared a draft report in <u>JOB/CTG/35</u> at the request of the Chairperson of the Council for Trade in Goods further to the Council's informal meeting of 31 May 2023<sup>14</sup>, and followed the template proposed in <u>RD/CTG/20</u>. The Chairperson of the CTG also conveyed these discussions to the Chairpersons of the CTG's 14 subsidiary bodies and invited them to a meeting that was held on 30 June 2023, where he explained the status of current work, and coordinated on how best to advance it.<sup>15</sup>
- 12.5. Further to discussions at the informal meeting of 19 September 2023 and comments from Members, a second revision was circulated in document  $\underline{\mathsf{JOB/CTG/35/Rev.2}}$  and  $\underline{\mathsf{JOB/CTG/35/Rev.2/Add.1}}$ . At its formal meeting of 30 November, the Council considered the report and agreed to transmit this report to the General Council for consideration at its December meeting. The adopted version of the report was circulated in document  $\underline{\mathsf{G/L/1521}}$ .
