The Report was prepared pursuant to the Procedures for an Annual Overview of WTO Activities and for Reporting under the WTO (WT/L/105) and sets out the actions taken by the Dispute Settlement Body (DSB) in the period since its previous Annual Report. 1

In carrying out its tasks, the DSB held 16 meetings since the period covered by the previous Report. The minutes of these meetings, which remain the record of the DSB's work, are contained in documents WT/DSB/M/458 – WT/DSB/M/473² and should be read in conjunction with this Report.

1 ELECTION OF CHAIRPERSON

4 ADOPTION OF THE 2022 DRAFT ANNUAL REPORT OF THE DSB

4.1. At the 28 November 2022 DSB meeting, the draft Annual Report of the DSB for 2022 contained in document WT/DSB/W/707 was adopted by the DSB as amended during that meeting, on the understanding that it would be further updated by the Secretariat in order to include the actions taken by the DSB at its meeting held on 28 November 2022. The updated and revised Report would be submitted for consideration by the General Council at its meeting on 19 and 20 December 2022 so that the General Council could take note of the Report (WT/DSB/M/473).

- "Dominican Republic Anti-Dumping Measures on Corrugated Steel Bars": The DSB considered, for the first time, Costa Rica's panel request at its meeting on 29 November 2021 (WT/DS605/2; WT/DSB/M/458). Costa Rica and the Dominican Republic made statements. The DSB considered this matter, for the second time, at its meeting on 20 December 2021 and agreed to establish a panel in accordance with the provisions of Article 6 of the DSU, with standard terms of reference (WT/DSB/M/459). In the course of the period covered by this report, the following delegations made statements: The European Union (3 times) and the United States (3).
 - "European Communities and Certain Member States Measures Affecting Trade in Large Civil Aircraft" (DS316): The United States raised the implementation of the DSB recommendations and rulings in this dispute at the DSB meetings held on 29 November 2021 (WT/DSB/M/458), 20 December 2021 (WT/DSB/M/459) and 25 January 2022 (WT/DSB/M/460). In the course of the period covered by this report, the following delegations made statements: The United States (3 times) and the European Union (3).

 - At the DSB meeting held on 7 July 2022 (WT/DSB/M/467), pursuant to the joint request by Korea and the United States, the DSB adopted a draft decision, as set out in document WT/DS546/9 pertaining to the dispute: "United States – Safeguard Measure on Imports of Large Residential Washers". The representatives of Korea and the United States made statements.
 - At the DSB meeting held on 5 October 2022 (WT/DSB/M/471), pursuant to the joint request by Korea and the United States, the DSB adopted a draft decision, as set out in document

WT/DS546/10 pertaining to the dispute: "United States – Safeguard Measure on Imports of Large Residential Washers". The representatives of Korea and the United States made statements.

10.7. At the DSB meeting held on 29 August 2022 (WT/DSB/M/469), Türkiye made a statement regarding its intentions with regard to the implementation of the recommendations and rulings in the DS583 dispute: "Türkiye – Certain Measures Concerning the Production, Importation and Marketing of Pharmaceutical Products". The European Union and the United States also made statements on this matter.

11 CONCLUSION

11.1. This brief overview demonstrates that, during the period from 29 November 2021 through 28 November 2022, the DSB was called upon to consider a variety of significant matters and took a number of important decisions. As set out in detail above, the DSB approved a total of seven new nominations proposed for inclusion on the Indicative List of Governmental and Non-Governmental Panelists. It established three Panels in accordance with Article 6 of the DSU. As part of its surveillance function, the DSB considered status reports on implementation with regard to six matters.
