COMPLIANCE WITH NOTIFICATION OBLIGATIONS

NOTE BY THE SECRETARIAT1

Revision

The present document has been prepared to assist with the consideration of the agenda item "overdue notifications" during the 107th meeting of the Committee on Agriculture to be held on 27-29 November 2023. It reflects Members' compliance with their regular notification obligations² as of 15 November 2023.

In preparing this note, the Secretariat has largely relied on the Agriculture Information Management System (AG-IMS). 3



1 NOTIFICATION REQUIREMENTS

- 1.1. There is a total of 12 distinct notification requirements applicable in the domain of agriculture covering the following five areas: (i) Market access (Tables MA:1 to MA:5), (ii) Domestic support (Tables DS:1 to DS:2), (iii) Export subsidies (Tables ES:1 to ES:3), (iv) Export prohibitions or restrictions (Table ER:1), and (v) Follow-up to the Marrakesh NFIDC Decision (Table NF:1). The applicability of a notification requirement to a Member is largely dependent on the specific commitments it has assumed under the Agreement on Agriculture. In many cases a limited number of notification requirements will apply for a particular Member. Simultaneously, there are a few notification requirements especially in the area of agricultural subsidization (i.e. Tables DS:1 and ES:1) that apply to all WTO Members.
- 1.2. Out of the 12 notification requirements, there are five "regular" or "annual" notification requirements, namely: Table MA:2, Table MA:5, Table DS:1, Table ES:1 and Table ES:2. Annual notifications are required to be submitted no later than a certain number of days following the end of the year in question. Regular notifications are required to be submitted by the concerned Members irrespective of whether they maintained any notifiable measure in a given year; in the absence of such measures a 'nil' notification should be submitted. The deadlines for submission of notifications vary per type of notification and are indicated below. For additional details refer to document G/AG/2.


Figure 1: Notifications submitted to the WTO (1995-2023*)

- 1.3. As of 15 November 2023, a total of 6,278 agriculture notifications (including addenda, corrigenda and revisions) have been submitted to the WTO. The number of notifications submitted to the WTO experienced a generally upward trend in recent years reaching a peak in 2019 with a total of 440 notifications, the highest number of submitted notifications since the CoA's inception (Figure 1).

- 1.4. For the period 1995-2021, there are a total of 1,934 outstanding regular notifications which represents around 22% of expected notifications.⁴ Out of the five annual notification requirements, Domestic Support (Table DS:1) and Export Subsidy (Table ES:1) notifications have the highest number of outstanding notifications with 34% (973 notifications) and 24% (785 notifications) of notifications pending, respectively.



- 1.5. Figure 3 below shows the number of outstanding notifications according to the category of Members maintained in the Secretariat database for statistical purposes (i.e. developed country, developing country and least developed country (LDC) Members).

1.1 Annual Notification Obligations

- 1.6. The time limits for notifications covering the 1995-2021 implementation years have now passed. The seven tables contained in part 2 of this document (under 'Compliance with Annual Notification Obligations') show Members' compliance with their notification requirements. The individual tables show only those Members to whom the notification requirement applies. The last column on each table shows the percentage of compliance by Member for the corresponding notification requirement. The tables contain information pertaining to the last 18 years (2005-2022). The column concerning the 2022 implementation year is provided for information only and does not necessarily indicate that the notifications are now due. The notifications circulated by the United Kingdom have been acknowledged in the relevant tables for the period after the end of the transition period on 31 December 2020.⁵ The full-time series (1995-2022) of compliance information is available in the "Compliance with notification obligations" section of the Agriculture Information Management System (http://agims.wto.org).
- 1.7. Members' compliance with their notification obligations varies greatly. The compliance also varies by type of notification. Only a few Members are 100% compliant (27 Members in DS:1 and 57 Members in ES:1) with all their notification requirements. Simultaneously, there is an important percentage of Members whose compliance with some of their notification obligations is 0% (27 Members in DS:1 and 14 Members in ES:1) (Table 1).

1.1.1 Table MA:1 notifications, comprehensive one-off (Implementation of tariff and other quota commitments; Article 18.2 – 30 days)

1.8. Table MA:1 notifications are required to have been submitted by all Members with tariff and other quota commitments, either in advance or within 30 days of the first opening of the tariff quotas concerned. Subsequent changes to the administration of tariff and other quotas are included in ad-hoc Table MA:1 notifications to be made within 30 days following the change.

1.1.2 Table MA:2 notifications (Imports under tariff and other quotas; Article 18.2 – 60 days)

- 1.9. Table MA:2 notifications are required to be submitted annually by Members with tariff and other quota commitments specified in Section I-B (or Section I-A) of Part I of their Schedules for the products concerned no later than 60 days following the year in question.





Figure 4: Compliance with MA:2 notifications, 1995-2021 (Number of Members)

- 1.10. For the period 1995-2021 there are 54 Table MA:2 notifications outstanding which represent 6% of the total MA:2 notifications expected for this period. Out of the 41 Members with this notification obligation, 28 are up to date with their notifications, whereas 12 Members have compliance rates between 50% and 99%, and only one Member is below the 50% threshold (Figure 4).

1.1.3 Table MA:5 notifications (Special Safeguard; Articles 5.7 and 18.2 – 30 days)

1.11. Table MA:5 notifications are required to be submitted annually by Members that have reserved the right to have recourse to the Special Safeguard provisions as indicated in Section I-A of Part I of their Schedules no later than 30 days following the year in question.

1.12. For the period 1995-2021 there are 85 Table MA:5 notifications outstanding which represents 10% of the total MA:5 notifications expected for this period. Out of 34 Members with this notification obligation, 22 Members are up to date with their obligations for the reported period. Ten Members have a compliance rate between 50% and 99%, one Member has a compliance rate between 1% and 49%, while another Member has a zero-compliance rate (Figure 5).

1.1.4 Table DS:1 notifications (Domestic support; Article 18.2 – 90 days or 120 days if the initial notification is provisional)

- 1.13. Table DS:1 notifications are required to be submitted annually by Members with base and annual commitment levels specified in Section I of Part IV of their Schedules no later than 90 days following the year in question. All other Members, except Least-Developed Country (LDC) Members, should submit an annual Table DS:1 notification. LDC Members are required to submit Supporting Tables DS:1 to DS:3 every other year (indicated by the symbol "(NA)").




Figure 6: Compliance with DS:1 notifications, 1995-2021 (Number of Members)

- 1.14. For the period 1995-2021 there are 973 Table DS:1 notifications outstanding. This notification category has the highest percentage of outstanding notifications with 34% of Table DS:1 notifications outstanding. The compliance rates for Table DS:1 vary greatly. There are 27 Members with 100% compliance, while 27 Members have a compliance rate of 0% (Figure 6).

1.1.5 Table ES:1 notifications (Export subsidies; Article 18.2 – 60 days or 120 days if the initial notification is provisional)

- 1.15. Table ES:1 notifications are required to be submitted annually by Members with base and annual commitment levels specified in Section II of Part IV of their Schedules no later than 60 days following the year in question. Members with no such scheduled commitments are required to submit an annual notification (within 30 days following the end of the year in question) in the form of a statement confirming that no export subsidies exist or, in the case of developing country Members using certain export subsidies pursuant to Article 9.4, in the form of Supporting Table ES:2.




Figure 7: Compliance with ES:1 notifications, 1995-2021 (Number of Members)

- 1.16. For the period 1995-2021 there are 785 Table ES:1 notifications outstanding which represents 24% of the total ES:1 notifications expected for this period. Like Table DS:1 compliance, Table ES:1 compliance rates vary greatly. A total of 57 Members have submitted all their corresponding notifications, whereas 14 Members have a 0% compliance rate (Figure 7).

1.1.6 Table ES:2 notifications (Total exports; Articles 10 and 18.2 - 120 days)

1.17. Table ES:2 notifications are required to be submitted annually by Members with export subsidy commitments specified in Section II of Part IV of their Schedules and by "significant exporters" as listed in G/AG/2/Add.1 no later than 120 days following the year in question. The modifications⁸ effected in Members' scheduled export subsidy reduction commitments pursuant to the December 2015 Nairobi Ministerial Decision on Export Competition (Nairobi Decision)9 have led to a modified/reduced product composition in concerned Members' Table ES:2 notifications, or in some cases, an eventual non-application of the ES:2 notification requirement. Some Members also submit a Table ES:2 notification on a voluntary basis based on the report by the Chairperson on the review of the list of significant exporters (G/AG/W/123).




Figure 8: Compliance with ES:2 notifications, 1995-2021 (Number of Members)

1.18. For the period 1995-2021 there are 37 Table ES:2 notifications outstanding which represents 5% of the total ES:2 notifications expected for this period. A total of 22 Members have submitted all of their corresponding Table ES:2 notifications. Additionally, four Members have a compliance rate between 50% and 99%. The remaining Member has a compliance rate below 50% (Figure 8).

1.2 Other Regular Notification Obligations Applicable only upon Maintenance of Specific Measures

1.2.1 Table ES:3 notifications (Food aid volumes; Articles 10 and 18.2 - 120 days)

1.19. Table ES:3 notifications are required to be submitted annually by all food donor Members for all donated products (except for those products in respect of which this information must be notified under Table ES:1) no later than 120 days following the year in question. No "nil return" is required from Members that do not provide food aid. From 1995 to 15 November 2023, a total of 244 Table ES:3 notifications have been submitted to the WTO (including addenda, corrigenda and revisions).

1.2.2 Table NF:1 notifications (Food and other aid in the context of the Marrakesh Decision; Article 16.2 – 60 days)

1.20. Table NF:1 notifications are required by all donor Members in respect of actions taken within the framework of the Decision on Measures Concerning the Possible Negative Effects of the Reform Programme on Least-Developed and Net Food-Importing Developing Countries no later than 60 days following the year in question. No "nil return" is required from Members that do not provide food aid or other assistance to the countries concerned. From 1995 to 15 November 2023, a total of 264 Table NF:1 notifications have been submitted to the WTO (including addenda, corrigenda and revisions).

1.3 Export Competition Questionnaire (ECQ) in Annex to Ministerial Decision on Export Competition (export subsidies, export credit, export credit guarantees or insurance programs, international food aid and agricultural exporting state trading enterprises)

1.21. The Nairobi Decision mandates the Committee to monitor the implementation of the Decision in accordance with the existing AoA notification requirements, as complemented by the provisions contained in the Annex to the Decision. The Annex to the Nairobi Decision states that, consistent with the Bali Declaration¹¹, Members shall continue to provide information on export subsidies, export credit, export credit guarantees or insurance programs, international food aid and agricultural exporting state trading enterprises, within the context of an annual examination process. This exercise is facilitated by an Export Competition Questionnaire (ECQ) following the structure of the Annex to the Nairobi Decision distributed every year to Members by the Secretariat. Since 2021, all Members have been required to reply to the ECQ following the expiry of the grace period pursuant

to footnote 17 of the Nairobi Decision. The year-wise record of Members' responses to the ECQ can be found in section 4 of this document. 12

1.4 Symbols and Abbreviations

A blank space (" ") indicates that the notification is outstanding.

A capital "x" (" \mathbf{X} ") indicates that a notification has been issued. No assessment on the content or quality of the notification with respect to requirements is made or implied.

A capital "x" followed by a superscripted star ("X*") indicates that the one-off Table MA:1 notification has been revised or supplemented.

A capital "p" (" \mathbf{P} ") indicates that a notification has been received and is either being processed or pending for want of feedback from the notifying Member. A pending notification will be marked as "P" for a maximum period of six months.

A capital "n" and a capital "a" ("**NA**") indicates that the requirement was not applicable during the period covered either because there were no relevant commitments (e.g. tariff quotas) or because the Member concerned was not yet a WTO Member.

A capital "n" and a capital "a" in brackets ("**(NA)**") indicates that domestic support notifications are required every second year from LDC Members.

Shaded cells indicate that the Member concerned has a scheduled domestic support and/or an export subsidy reduction commitment.

The **European Union** refers to EU-15 from 1995, EU-25 from 2004, EU-27 from 2007, EU-28 from 2013 and EU-27 from 2021 following the departure of the **United Kingdom**. The **United Kingdom** ceased to be a member State of the European Union on 1 February 2020; the annual agriculture notifications by the European Union include information in respect of the United Kingdom for the implementation years 1995-2020.

Switzerland in all tables refers to Switzerland-Liechtenstein, except in tables 3.2 and 4.1.

2 COMPLIANCE WITH ANNUAL NOTIFICATION OBLIGATIONS

2.1. "Compliance (%)", shown in the last column of tables 2.1 to 2.5 below, is calculated based on the number of reported years covered by each Member's notifications, issued as of 15 November 2023, compared to the total number of implementation years applicable to that Member for the period 1995-2021. A 100% compliance for a notification obligation signifies the circulation of all relevant notifications due for the period 1995-2021 before the cut-off date of 15 November 2023; it does not take into account the actual date of submission/circulation of the notifications. The compliance percentage does not therefore take into account the "timeliness" aspect of the notifications. The 'compliance' in this document also does not take into consideration the quality or content of the notifications submitted. In view of the different types of implementation 'years' (calendar, marketing, financial, etc.) used in Members' annual notifications, the year '2022' has not been used in the calculation of compliance as notifications for 2022 may not necessarily be due in all cases. Members' notifications for 2022, circulated as of 15 November 2023, have been acknowledged in the tables. Detailed information on compliance (for 1995-2022) may also be consulted under the "Compliance with notifications" section of the Agriculture Information Management System (http://agims.wto.org/).
