In order to maintain an economically sustainable price on the internal market for domestic products such as wheat, maize and sunflower, the Commission for Exceptional Situations of the Republic of Moldova imposed the temporary measure on the licensing imports for certain products for a period of three months (Disposition no. 98 of December 27, 2023, website link of the new regulation:
