Ukraine notifies the adoption of the Resolution of the Cabinet of Ministers of Ukraine of 30 January 2024 No. 95 "On Amendments to Annex 1 to the Resolution of the Cabinet of Ministers of Ukraine of 27 December 2023 No. 1402", according to which the tariff codes described in column 3 for fuel wood, in logs, in billets, in faggots, in twigs or in similar forms; wood in chips or particles should be added with the tariff code 4401 22 90 00.

The measure is effective from 31 January 2024.
